Ms. Fiocco,

As a part of the budget for the Office of the Adjutant General, the State's 2022-2023 General Appropriations Bill includes Earmarked Appropriations (Pass Thru) funding designated for AmeriCorps (i.e., AmeriCorps - State Match) in the amount of \$338,000.

In accordance with Proviso 117.21. (Organizations Receiving State Appropriations Report), NLT 01 November, organizations receiving state appropriated funds are required to provide to the State Agency providing those funds certain information and documentation prior to receiving those funds.

In addition, the organization is required to submit Quarterly Reports on the status of the

disbursement of those funds, and a final set of reports prior to the end of the Fiscal Year (prior to 30 Jun 2023).

The Agency is required to provide this information to the Executive Budget Office, the Chairman of the Senate Finance Committee, and the Chairman of the House Ways and Means Committee.

I have attached copies of the forms developed to meet the required request for funds and the quarterly reporting, as well as a copy of Proviso 117.21.

Complete the information on the spreadsheets to request the funds and for the accounting of funds for 1<sup>st</sup> Quarter of FY 22-23. Provide me the completed spreadsheets in the original Excel format, and a copy of the signed forms (.pdf signed electronically is preferred) as soon as possible.
